The grades of membership are:

**Company** – Companies and organisations involved in the training of tutors, trainers, operators and others for the operation and maintenance of equipment, approved for that purpose where appropriate by an accrediting body recognised by the Health and Safety Commission.

**Self-employed Instructor** – An individual offering commercial training who is approved as a training organisation by an accrediting body recognised by the Health & Safety Commission. (Have to be annually monitored to be accredited as an AITT training provider)

**Employed Instructor** – Registered tutor or trainer who is an employee or solely Sub-contracting but does not issue certificates under his own name.

**Associate** – A company or individual who has an interest in improving safety and training standards, but do not, themselves, carry out training.
